#### **Description of the organisation**

ISCTE - University Institute of Lisbon (ISCTE-IUL) is a public university established in 1972 pursuing teaching, research and community service activities. ## • Mapping Out: Portugal on the European anti-immigrant movements map

"Mapping Out: Portugal on the European anti-immigrant movements map" adds to the "Reaching Out to Close the Border: The Transnationalization of Anti-Immigration Movements in Europe (MAM)" project, led by Kristian Berg Harpviken (PRIO), by incorporating the Portuguese case to its analysis. MAM looks at contemporary European anti-immigration movement in Germany, Italy, Poland, Norway and the UK, analyzing their transnational dynamics and its impact on their national migration agendas. Hence, "Mapping Out" aims to be part of a wider transnational collaboration that focuses on a cutting-edge topic in the migration and social movement's field. The well-constructed myth about Portugal as a non-racist society has deemed anti-immigrant movements as an absent issue in the country. In 2019, however, the election of a MP affiliated to the far right party raised public awareness to the problem as it attested to the growing support for racist and xenophobic ideas by the population. Against this backdrop, our initiative aims at expanding the knowledge on the Portuguese anti-immigrant movement, following MAM's threefold analytical focus: 1) interaction (forms and consequences), 2) framing (political-ideological underpinnings) and 3) outcomes (on migration policies). https://mappingout.iscte-iul.pt/

#### Iberian Digital Media Research and Fact-Checking Hub

IBERIFIER is an Iberian hub that aims to tackle disinformation in Spain and Portugal by bringing together aconsortium of 23 partners, composed of 12 universities, 5 independent fact-checking organisations and publicly-owned news agencies, and 6 leading institutions on strategic analysis, computer and data science, and mediaresearch. With the support of public authorities of both countries, relevant media organisations, several scientific andprofessional associations, as well as some other stakeholders, the activities of this Action comprise: (1) scientificresearch and analysis for the security and development of the Iberian digital media ecosystem; (2) fact-checking inthree languages



(Spanish, Portuguese, and Catalan); (3) computer and data research aimed at developing systemsfor early detection of disinformation; (4) strategic analyses about the impacts of disinformation on areas such aspolitics, economy, social and security issues, science and technology, and the media industry; and (5) developmentof media literacy, through a set of activities targeted mainly to young people, journalists and citizens in general. Although the consortium focuses its activities on Spain and Portugal, its impacts are expected to reach far beyondthese two countries, thus contributing to the overall strategy and goals of the European Digital Media Observatory. Thanks to the international dimension of some of the consortium partners, as well as the set of scientific, communication and dissemination activities planned, IBERIFIER aims to have impact in the socio-cultural andlinguistic area that comprises all the Iberian-American region as well as some other countries in Africa and Asia, where Spanish and Portuguese languages are spoken by more than 600 million people, spread over 21 Spanish-speaking and 9 Portuguese-speaking countries.

#### • Third country students in Portugal: challenges of integration in a (post)pandemic era

This project aims to analyze the impact of the Covid-19 pandemic on the experience of third-country nationals as international students in higher education in Portugal, based on the students' own perceptions. By international students we mean both students enrolled in 'credit' mobility schemes, who generally stay in Portugal for one or two semesters, as well as students in 'degree' mobility, that is, enrolled in a degree awarding course at an institution of Portuguese higher education. To this end, the following research objectives were defined: to examine the changes in the profiles of international students from third countries who entered the country since the beginning of the Covid-19 pandemic, and to investigate how international students from third countries assess and give meaning their experiences during the (post)pandemic period. Furthermore, this study aims to map the new challenges and opportunities that the health crisis has brought to the internationalization of Portuguese higher education. Considering the popularization of new forms of mobility designed for the context of tertiary education, we intend to understand the role that 'virtual mobility' and 'hybrid mobility' can play in Portuguese higher education. In addition to its academic objective, the project seeks to produce policy recommendations based on scientific evidence to support the work of policy makers, institutional stakeholders, experts and professionals in the field of higher education and migration. Aiming for a comprehensive understanding of this phenomenon in the Portuguese context, the analyzes proposed here will be carried out at a national level.

# • Health equity in times of a pandemic: impact assessment on mental health and well-being of the Brazilian and Cape Verdean population in Portugal

The EQUALS4COVID19 project aims to assess the impact of the COVID-19 pandemic on the mental health and physical, mental and social well-being of the immigrant population in Portugal, and, in particular, of young individuals, adults and older adults with Brazilian nationality and Cape Verdean and residents in the districts of Lisbon, Faro, Porto and Setúbal, including individuals who were/were in quarantine or isolation, due to infection or suspicion, taking into account various factors, from anxiety, depression, post-natal stress trauma, burnout and resilience, factors related to work-family conciliation, perceived social support, work situation and financial income and expectations for the future. Its specific objectives and for population subgroups in terms of nationality, gender, age group, and district under study: 1. Identify the modifiable factors of protection or weakening of mental health in a pandemic context; 2. Characterize the perceived access to health services and individual protection measures; 3. Produce recommendations for the public policy for the integration of NPT immigrants and asylum seekers and good practices for the training of health professionals as privileged agents for the promotion of mental health and well-being with respect for individual and cultural diversity.

• Monitoring and Evaluation of Territorial Impacts of public policies through a platform: Impact-WEB-SIG It proposes to develop an innovative methodology for monitoring and evaluating the impacts of public policies supported by a WEB-GIS platform to be built and the respective analytical information system. The evaluation methodology will be developed focusing on the Operational Program for Sustainability and Efficiency in the Use of Resources (PO SEUR - 2014-2020) and will be based on the analysis of implemented projects, available statistical data and qualitative data from interviews to be carried out. Once ready, the methodology can be adjusted for various areas of intervention (eg implementation of the 2030 strategy or the Cohesion Policy in general, or each of its axes of intervention - and even specific components such as Biodiversity) and to various territorial scales (counties, NUTS 3 and NUTS 2).

According to the results of the Survey on Special Needs for Education in Higher Education Establishments in 2019/2020 of the Directorate-General for Education and Science Statistics (DGEEC), as a Delegated Entity of the National Institute of Statistics, there is a need to frame the students with special needs in higher education in Portugal, as well as the development of physical and digital accessibility conditions, topics to be studied in the work package presented by the project, constituting an opportunity to discuss and train the inclusion of these students. It is also essential that these issues are reflected in their dimension of designing university and education policy guidelines, as a whole, a need that fits into work package 3.
